amongst the disputants rather than shipping them to the safe coast. Actually this is one amongst the reasons for the adoption of the Alternative Disputes Resolutions hereinafter referred to as ADR as another form of settling disputes. ADR encourages disputants to settle their disputes out of the court. There are several modes under ADR including but limited to mediation, arbitration, negotiation and early neutral case evaluation.
