## 5 Types of ADR



### Negotiation

Traditionally occurs directly between the parties & their counsel & does not involve a neutral third party.



### Mediation

Very flexible process that can be effectively used at any time during the dispute.



### Collaborative Law

Collaborative attorney represents both parties, & both parties agree not to litigate.



### Arbitration

Neutral arbitrator renders a decision, called an award, after there has been a presentation of evidence.



### Conciliation

Neutral third party to communicate with the parties in the exchange of information & settlement options.
