


# 10 Must-Know

## OSHA Standards for Industrial Companies



### Hazard Communication Standard

This standard applies to companies with production operations that use hazardous chemicals.



### Emergency Action Plans

If you have over 10 employees, then you need to write an EAP that addresses all potential emergency scenarios.



You must have a written respiratory program that employees are trained in. Additionally, annual fit testing must occur, and your facility need to be evaluated whenever operations change.



### Electrical Wiring & Systems Design

As a part of this standard, you need to tag-out and remove from service all damaged equipment, maintain a 36-inch minimum clearance near each electrical panel, and more.



### Powered Industrial Trucks

Applies to forklifts, cherrypickers, and any battery-operated pallet jacks. Employees must be trained and must wear seatbelts when operating powered industrial trucks.



### Control of Hazardous Energy

Often referred to as "Lockout/Tagout"- You need to develop, document, implement, and enforce energy control procedures of equipment from sources of hazardous energy.



### Personal Protective Equipment

Employers must provide PPE and ensure that it is used whenever necessary. This includes workplace assessment, employee training, and written certification.



### Machinery & Machine Guarding

Requires that facilities review their equipment to make sure that proper protection is in place. Examples of safeguarding include barrier guards, 2-handed tripping devices, and electronic safety devices.



### Toxic & Hazardous Substances

OSHA currently regulates approximately 400 substances, and has been focusing heavily on employees who may be exposed to hexavalent chromium and lead.



### Hearing Conservation

The Noise Exposure standard establishes acceptable levels of noise that employees may be exposed to during their work shift.

## **Osha Safety Guidelines:**

Training Requirements in OSHA Standards and Training Guidelines U.S. Department of Labor, Occupational Safety Administration, 2014-03-18 Many standards promulgated by the Occupational Safety and Health Administration OSHA explicitly require the employer to train employees in the safety and health aspects of their jobs Other OSHA standards make it the employer's responsibility to limit certain job assignments to employees who are certified competent or qualified meaning that they have had special previous training in or out of the workplace The term designated personnel means selected or assigned by the employer or the employer's representative as being qualified to perform specific duties These requirements reflect OSHA's belief that training is an essential part of every employer's safety and health program for protecting workers from injuries and illnesses Many researchers conclude that those who are new on the job have a higher rate of accidents and injuries than more experienced workers If ignorance of specific job hazards and of proper work practices is even partly to blame for this higher injury rate then training will help to provide a solution As an example of the trend in OSHA safety and health training requirements the Process Safety Management of Highly Hazardous Chemicals standard Title 29 Code of Federal Regulations Part 1910 119 contains several training requirements This standard was promulgated under the requirements of the Clean Air Act Amendments of 1990 The Process Safety Management Standard requires the employer to evaluate or verify that employees comprehend the training given to them This means that the training to be given must have established goals and objectives regarding what is to be accomplished Subsequent to the training an evaluation would be conducted to verify that the employees understood the subjects presented or acquired the desired skills or knowledge If the established goals and objectives of the training program were not achieved as expected the employer than would revise the training program to make it more effective or conduct more frequent refresher training or some combination of these The requirements of the Process Safety Management Standard follow the concepts embodied in the OSHA training guidelines contained in this booklet The length and complexity of OSHA standards may make it difficult to find all the references to training So to help employers safety and health professionals training directors and others with a need to know OSHA's training related requirements have been excerpted and collected in this booklet Requirements for posting information warning signs labels and the like are excluded as are most references to the qualifications of people assigned to test workplace conditions or equipment It is usually a good idea for the employer to keep a record of all safety and health training Records can provide evidence of the employer's good faith and compliance with OSHA standards Documentation can also supply an answer to one of the first questions an accident investigator will ask Was the injured employee trained to do the job Training in the proper performance of a job is time and money well spent and the employer might regard it as an investment rather than an expense An effective program of safety and health training for workers can result in fewer injuries and illnesses better morale and lower insurance premiums among other benefits OSHA Safety and
