Air Mobility Operations (Joint Publication 3-17) Chairman of the Joint Chiefs of Staff, 2012-10-01 This publication provides joint doctrine for planning employing and assessing air mobility operations across the range of military operations Air mobility is a network of systems that combines airlift airdrop aeromedical evacuation AE air refueling AR and air mobility support assets processes and procedures into an integrated whole to support the transport of personnel and materiel The Secretary of Defense SecDef directs the assignment of air mobility forces to the Commander United States Transportation Command CDRUSTRANSCOM and other combatant commanders CCDRs To deter threats against or to assist in the defense or pursuit of United States US national interests the Department of Defense maintains forces organizations and processes necessary to conduct air mobility operations The National Air Mobility System NAMS is a broad and comprehensive system that provides the President SecDef and CCDRs with rapid global mobility The mobility air forces MAF are those forces assigned to combatant commands that provide rapid global mobility and conduct air mobility operations The MAF's four core functions are airlift AR air mobility support and AE NAMS consists of forces that perform intertheater intratheater and organic mobility operations US Transportation Command USTRANSCOM and the geographic combatant commands GCCs possess air mobility assets that are capable of performing both intertheater and intratheater operations A unique aspect of these operations is their reliance on Global Air Mobility Support System GAMSS and the worldwide command and control C2 capabilities of the Air Mobility Command 618th Tanker Airlift Control Center 618th TACC The GAMSS is comprised of a limited number of permanent en route support locations plus mobile forces that deploy under the global reach laydown strategy This publication has been prepared under the direction of the Chairman of the Joint Chiefs of Staff It sets forth joint doctrine to govern the activities and performance of the Armed Forces of the United States in joint operations and provides the doctrinal basis for interagency coordination and for US military involvement in multinational operations It provides military guidance for the exercise of authority by combatant commanders and other joint force commanders JFCs and prescribes joint doctrine for operations education and training It provides military guidance for use by the Armed Forces in preparing their appropriate plans It is not the intent of this publication to restrict the authority of the JFC from organizing the force and executing the mission in a manner the JFC deems most appropriate to ensure unity of effort in the accomplishment of the overall objective Joint doctrine established in this publication applies to the joint staff commanders of combatant commands subunified commands joint task forces subordinate components of these commands and the Services The guidance in this publication is authoritative as such this doctrine will be followed except when in the judgment of the commander exceptional circumstances dictate otherwise *Air Mobility Operations* U.S. Joint Force Command, 2014-07-25 Air mobility is the rapid movement of personnel materiel and forces to and from or within a theater by air This includes both airlift and air refueling AR The air mobility network combines airlift AR aeromedical evacuation AE and air mobility support

Costello,1997 Doctrinal differences over the employment of airpower are as old as military aviation itself One particular area of contention has been close air support CAS The two primary issues related to CAS are its command and control and responsiveness Soldiers have argued that ground commanders should control their own aircraft because ownership assures that airpower directly responds to their needs Airmen have maintained that airpower should be centralized under a single air commander to allow for its flexible theaterwide employment During World War 2 Korea Vietnam and Desert Storm ground commanders demanded greater influence over airpower employment Concurrently the Air Force disagreed with the Navy and Marine Corps over centralized versus decentralized control of air assets These two issues of command and control and responsiveness are embodied in the process of apportioning and allocating CAS In all conflicts since World War 2 the United States has had the luxury of an overabundance of air assets Despite a facade of centralization airpower was parceled out to fill nearly everyone s needs This avoided the need for any difficult choices This study follows the history of CAS since World War 2 to examine how it has been apportioned and allocated in the past It then examines the current joint air operations process It is the contention of this study that the current system rooted in its historical past does not fully employ CAS to its optimum potential The historical view of CAS has been as a tactical measure with limited localized effects However properly integrated and coequal with the ground scheme of maneuver it can have operational level effects This study examines two theories of the use of CAS at the operational level and then recommends changes to the view of CAS and the process for its apportionment and allocation
