$$\therefore e^x = \frac{3}{2} \text{ or } e^x = 2$$

$$\therefore x = \ln \frac{3}{2} \text{ or } x = \ln 2$$

(b) $|2x + 3| = 5x - 2$

$$|2x + 3| = 5x - 2$$

$$2x + 3 = 5x - 2 \text{ or } 2x + 3 = -(5x - 2)$$

$$\therefore 5 = 3x \text{ or } 7x = -1$$

$$\therefore x = \frac{5}{3} \text{ or } x = -\frac{1}{7}$$

a check reveals that $x = \frac{5}{3}$ only

(c) Solve $\frac{(-x^2 - 5)(x^2 - 16)}{|x + 3|(x + 2)} \geq 0$


$$\frac{(-x^2 - 5)(x^2 - 16)}{|x + 3|(x + 2)} \geq 0$$
