With a broad perspective on feminist lawmaking as a vehicle of social change, Schneider examines subjects as wide ranging as criminal prosecution of batterers, the civil rights remedy of the Violence Against Women Act of 1994, the O J Simpson trials and a class on battered women and the law that she taught at Harvard Law School.
