



# TAX CLASSES IN GERMANY

**I**

**Single Earners**  
(e.g., single, divorced)

No tax if you earn less than the basic tax-free allowance

**II**

**Single Parents**  
(has at least 1 child)

They will receive a tax relief amount (Entlastungsbetrag) and a basic tax-free allowance.

**III**

**Married Couples**  
(Higher-Earning Spouse)

The spouse with higher income (up to 60% of the family income) should opt for this tax class, as you get twice the basic tax-free allowance.

**V**

**Married Couples**  
(Low-Earning Spouse)

The spouse with lower income opts for this tax class. They won't get any tax allowances.

**IV**

**Married with Equal Income**

The tax deduction is similar to that in tax class 1. Tax class 4 makes sense if both partners earn almost the same income.

**IV**

**Married with Fair Taxes**

The factoring technique ensures a fair distribution of the salary tax burden within a marriage. However, filing the tax is compulsory if you opt this tax class.

**VI**

**Multiple Jobs**

The second and additional jobs are taxed at the highest rate, with no tax-free allowances.
