  - – deductive arguments state that the truth of the conclusion validates the truth of the premises, while inductive arguments state that if the premises are true, then the conclusion is likely to be true.
  - Strawman Fallacy
  - – misrepresenting an argument to discredit it
  - Ad Hominem Fallacy
  - – attacks the person and not the argument
  - False Dichotomy Fallacy
  - - "or" statements, restricts the circumstances to two outcomes
  - Accidental Correlation Fallacy
  - – assumes 2 events are directly related and eliminates a possible third cause
  - Slippery Slope Fallacy
  - -If one event occurs, a series of events are likely to follow.
