

Registration forms are open for at most one year, then you will either have to create a new form altogether or copy and/or archive an existing form.

**Copying an existing form will do several things:**

- Optionally archive your old registration data so when you run a search you will not be searching last years or last registration period's data.
- Optionally archive and rename the old registration form, while renaming your newly-created form to what you desire.
- Make your registration form identifiable in Registration Searches.
- Create the new registration form as an exact replica of your current form.
- The expiry date on the new form will be one year after the date the form is created.

If you do not want to create a new payment schedule and archive your current registration data, advance the closing date to after today's date on step 1 of your registration form.

Note that this cannot be done after the registration form is older than one calendar year.
